

## BLUESTACK'S REWARDS SWEEPSTAKES – October 2025

### OFFICIAL RULES

Now.gg, Inc., 2105 S. Bascom Avenue, #380, Campbell, California 95008, USA (“BlueStacks” or “Sponsor”) is pleased to introduce the BlueStack’s Rewards Sweepstakes – October 2025 (the “Promotion”). The Promotion begins at 12:00:00 a.m. Greenwich Mean Time (“GMT”) on October 1, 2025, and ends at 11:59:59 p.m. GMT on October 31, 2025 (“Promotion Period”). Greenwich Mean Time shall control for all purposes of this Promotion. Sponsor’s computer shall be the official clock for purposes of the Promotion. The Promotion is subject to applicable federal, state and local laws and regulations and is VOID WHERE PROHIBITED OR RESTRICTED BY LAW.
